

**TurboTax for Online Banking \$15K Sweepstakes
OFFICIAL RULES**

NO PURCHASE, PAYMENT OR FINANCIAL DISCLOSURE OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT OR FINANCIAL DISCLOSURE WILL NOT INCREASE YOUR CHANCE OF WINNING. OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA, 18 YEARS OF AGE AND OLDER AT TIME OF ENTRY. VOID IN PUERTO RICO AND WHERE PROHIBITED BY LAW.

DESCRIPTION/ENTRY PERIOD: The TurboTax for Online Banking \$15K Sweepstakes (the "Sweepstakes") begins on January 5, 2012 at 12:00:01 a.m. Eastern Time ("ET") and ends on April 18, 2012 at 11:59:59 p.m. ET (the "Promotion Period").

ELIGIBILITY: The Sweepstakes is open to legal residents of the fifty (50) United States or the District of Columbia, 18 years of age or older at time of entry. Employees of Intuit Inc. (the "Sponsor"), its parent company, affiliates, subsidiaries, participating Financial Institutions, advertising agencies, prize suppliers, Marden-Kane, Inc. and the immediate families (spouse, parents, children, siblings and their respective spouses) and individuals living in the same household as such employees are not eligible to enter or win a prize. Sweepstakes is subject to all applicable federal, state and local laws. Void in Puerto Rico and where prohibited by law.

HOW TO ENTER: There are two ways to enter. **Online Entry:** You can enter by: [1] Sign into your financial institution's online banking account; [2] Click on the My Turbo Tax tab; [3] Follow the onscreen instructions to start a free tax return including providing a valid email address to automatically receive one (1) entry into the Grand Prize Drawing as well as one (1) entry into the First Prize Drawing (as indicated in the Entry Table below). **Mail-In Entry:** To enter without signing in to a TurboTax account during the promotion period, hand-print your name, address, city, state, zip code, daytime phone number, and email address (optional) on a plain 3"x5" piece of paper, place in a stamped envelope and mail to: TurboTax for Online Banking \$15K Sweepstakes, P.O. Box 212, Lynbrook, NY 11563-0212. Limit of one entry per mailing envelope. Envelopes containing multiple entries will be disqualified. Sponsor is not responsible for lost, late, damaged, delayed, destroyed, misdirected, incomplete, illegible, mutilated, or postage due mail. Photocopies, mechanically reproduced, forged or altered mailed entries and facsimiles are void. Incomplete or illegible entries are not eligible. All entries become the property of the Sponsor and will not be returned. No entries may be submitted on behalf of another person. Limit of one (1) entry per person or email address regardless of method of entry.

Entries received will be included into the First Prize Drawing for the Month the entry was received, as well as subsequent First Prize Drawings.

All Entries must be submitted by 11:59:59 p.m. ET on April 18, 2012 as determined by Sponsor's computer.

Users who do not sign in to their TurboTax account via their participating financial institution's website, or complete a mail-in entry, will not be entered into the Sweepstakes. NOTE: YOU WILL NOT RECEIVE A MESSAGE CONFIRMING YOUR ENTRY. Entries using macro, script or other forms of automatic entry will be disqualified. Incomplete or illegible entries are not eligible. All entries become the property of the Sponsor and will not be returned. No entries may be submitted on behalf of another person. Limit of one (1) entry per person or email address regardless of method of entry.

PRIZES: One (1) Grand Prize Winner: A Check for \$15,000. Retail Value, ("RV") \$15,000. Four (4) First Prizes: A Check for \$500. Retail Value, ("RV") \$500 each. Retail Value of all prizes is \$17,000. All federal, state, local tax (as applicable) and other tax liabilities (including income and withholding taxes) arising from prize acceptance and use are the sole responsibility of each Winner. RANDOM DRAWINGS: On or about the dates indicated above in the Entry Table, a random drawing will be conducted from among all eligible entries received under the supervision of Marden-Kane, Inc., an independent judging organization, whose decisions are final and binding in all matters relating to this Sweepstakes. Sponsor reserves the right to disqualify participants who violate these Official Rules or interfere with this Promotion in any manner. Each participant may enter only one (1) time during the Promotion Period, regardless of method of entry. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated entry software is prohibited. Electronically reproduced, illegible, incomplete or inaccurate entries are void. In case of a dispute as to the owner of an online entry, online entry will be deemed to have been submitted by the authorized account holder of the email address from which the entry is made. The authorized account holder is deemed as the natural person assigned to an e-mail address by an Internet access provider, service provider or other organization responsible for assigning email addresses or the domain associated with the submitted email address. Sponsor, its parent company, affiliates, subsidiaries, divisions, advertising and promotion agencies, Marden-Kane, Inc. and all of their officers, directors, shareholders, employees, and agents (collectively "Releasees") are not responsible for incorrect or inaccurate transcription of entry information, or for any human or printing error, technical malfunctions, lost/delayed data transmission, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, inability to access any online service or web site, inability to submit the online registration form, or any other error or malfunction, or any injury or damage to participant's or any other person's computer related to or resulting from participation or downloading any materials in this promotion, or for late, lost, stolen, illegible or misdirected entries.
